 The sensors and cables must not be operated under electrostatically critical process conditions. Avoid strong steam or dust currents that act directly on the connection system.

- The Memosens measuring cable CYK10 and its plug-in head must be protected against electrostatic charges if they pass through Ex zone 0.
- Hazardous area versions of Memosens cables have an orange/red ring.
- The maximum permitted cable length is 100 m.
- Compliance with the regulations for electrical installations in hazardous areas (EN/IEC 60079-14) is mandatory when using devices and sensors.
- Pay attention to the ex-related safety instructions of the transmitter and sensors when cabling.

Connection

Ex specification

The approved CYK10 cable is used to connect to the ATEX-/IECEx-approved intrinsically safe sensor output circuits of the Liquiline CM42 (e.g. with sensor module FSDG1) or Liquiline CM44 (e.g. with communication module 2DS Ex-i) transmitter. The cable can alternatively be used with devices that are certified with ATEX/IECEx Ex approval. These must have an intrinsically safe Memosens sensor output specified with the following maximum values. In particular, the certified intrinsically safe sensor output may not exceed the effective inner inductance and capacitance of the values indicated below:




